### **MAJOR AND CONNECTED TRANSACTION FURTHER DELAY IN DESPATCH OF CIRCULAR**

Reference is made to the announcement of EverChina Int'l Holdings Company Limited (the “**Company**”) dated 26 March 2025 and 15 May 2025 (the “**Announcements**”) in relation to, among other things, the proposed acquisition of the Property which constitutes a major and connected transaction under the Listing Rules.
